PSC STANDS IN SOLIDARITY WITH GUYANA ON BORDER CONTROVERSY

"The longstanding border controversy between the Co-operative Republic of Guyana and the Bolivarian Republic of Venezuela arose as a result of the Venezuelan contention that the Arbitral Award of 1899 about the frontier between British Guiana and Venezuela is null and void. On 30 January 2018, Secretary-General Antonio Guterres, following a careful analysis of developments in 2017, chose the International Court of Justice as the means to be used for the solution of the controversy." (UN Political and Peacebuilding Affairs, 2023) (for full article click here).

The last quarter of 2023 saw Venezuela heighten tensions between the two countries by intensifying its claims to two-thirds of Guyana's territory. The government of Venezuela further inflamed tensions, by holding a referendum to have its citizens vote on the matter, despite an ICJ ruling against the move. While the Government of Guyana worked tirelessly to ensure that the situation is resolved peacefully, Guyanese united in a show of solidarity.

As patriotic citizens of Guyana, and with a vested interest in Guyana's political and economic stability, members of the private sector lent support to the ongoing efforts. Staff of the business services organizations were informed of history and ongoing efforts, while PSC executives met with members of the diplomatic corps to solicit their stances and support on behalf of the

Guyanese people.

During the course of the month of October, the Commission was appalled at the public statements made against its Chairman, Mr. Komal Singh, by Mr. Joel Bhagwandin. These defamatory statements, challenged the leadership of the Chairman, and even ventured to make ghastly iterations against the private sector itself.

Mr. Singh, CEO and founder of GAICO Construction Inc. was duly elected to the post of Chairman of the PSC during its Annual General Meeting in April 2023. During his tenure, Mr. Singh has led the Commission with integrity and a steady hand, leading the largest overseas trade mission (to the Dominican Republic), ensured the visibility of the PSC at relevant expos and working tirelessly to fulfil the mission and objectives of the PSC.

In press statements, both the Executive and the Council of the PSC expressed their unwavering support of and confidence in the Chairman in the performance of his duties.



PSC 31st Anniversary Gala and Award Ceremony

In what was dubbed a Night of Excellence, members of the business community along with stakeholders, attended the Private Sector Commission's 31st Anniversary Gala and Awards Ceremony at the Guyana Marriot Hotel on December 19, 2023.

The formal proceedings commenced with a tribute given by Chief of Staff of the Guyana Defense Force, Brigadier Omar Khan the five fallen soldiers, followed by remarks given by PSC Chairman Komal Singh. The Chairman expressed his appreciation to those in the private sector who would have contributed to the growth of Guyana's economy, and pledged that the private sector will continue to work with the government in the new year to further develop the country.

In attendance was Ambassador Nicole Theriot, US Ambassador to Guyana, who delivered the Guest Speaker address stating that "the US is proud to be Guyana's preferred partner in its economic development, and greatly values its partnership with the PSC."

President Irfaan Ali, the Featured Speaker, encouraged the private sector to continue to make big investments in Guyana stating "If you look at where the jobs were created, the maximum number of jobs were created in the services sector, followed by agriculture, followed by manufacturing. That is a very interesting story; when one asks how is the diversification of the economy going, this tells the story."

It was also announced by His Excellency that Guyana is in discussions with Canada on a new training initiative that will see beneficiaries landing jobs with a starting salary of US\$30,000 a year. In the first phase, Dr Ali said the initiative will target 2,000 Guyanese, training them in "essential skills" that will be certified by the best.

Awards were presented to outstanding businesses and individuals who contributed to the work of the PSC and the growth and development of Guyana's private sector over the past three decades.

While the key purpose of an overseas mission is to assist a country's citizens abroad, embassies and consulates also aid in advancing their countries economic aspirations. To this end, the PSC hosted a business dinner for the heads of Guyana's diplomatic missions overseas. In his remarks, Minister of Foreign Affairs and International Relations, Minister Hugh Todd encouraged the private sector to think big and alluded to more conversations and improved synergies between the government and the private sector.

He specifically highlighted the high quality of Guyana's wood and expressed his interests in trading of wood between the EU and Guyana and fostering partnership with Guyana Forestry Commission. the However, among the possible concerns, placed emphasis was on pricing, sustainability without affecting Guyana's livelihoods, and tariffs and duties. He then collaboration between encouraged Guyana and the European Investment Bank. Finally, he and the PSC exchanged positive views on their future collaboration with Guyana's private sector as a whole.



CUBAN AMBASSADOR



The Private Sector Commission on October 23, 2023 hosted the Cuban Ambassador to Guyana, His Excellency Jorge Francisco Soberon Luis, and a business delegation at its headquarters. The delegation expressed interest in partnership with Guyanese businesses in developing the honey industry. Global trade in honey in 2021 amounted to US\$2.89 B, with Guyana producing some 93 metric tonnes in the same year.

During the recently concluded Agri Investment Forum and Expo, the Government of Guyana through the Ministry of Agriculture signed an MOU with the Government of Cuba to advance technical cooperation for increased honey production in Guyana.
